



## UTILITY BILLING RELIEF PROGRAM

### Acceptable Forms of Identification

UBR applicants must provide valid identification for all household members. **For customers who have been issued a Social Security card, this is required.** For customers who have not been issued a Social Security card, please submit any one of the following:

1. <b>Current Chicago CityKey Card</b> ( <a href="https://www.chicityclerk.com/chicagocitykey">https://www.chicityclerk.com/chicagocitykey</a> )
2. <b>U.S. Passport or U.S. Passport Card</b>
3. <b>Foreign Passport</b> , issued by a country other than the U.S. (machine readable)
4. <b>Consular Identification Card</b> (e.g. Matricula Consular)
5. <b>State Driver's License or Learner's Permit Identification Card</b>
6. <b>State Identification Card</b>
7. <b>Global Entry Card</b> issued by the U.S. Customs and Border Protection
8. <b>Illinois Temporary Visitor Driver's License (TVDL)</b>
9. <b>Illinois Firearm Owners Identification Card (FOID) Card</b>
10. <b>U.S. Permanent Residency Card</b> ("green card") or Alien Registration Receipt Card (Form I-151)
11. <b>U.S. Certificate of Citizenship</b> (Form N-560 or N-561)
12. <b>U.S. Certificate of Naturalization</b> (Forms N-550, N-570, or N-568)
13. <b>Verification of Release Form</b> issued by the U.S. Department of Health and Human Services- Office of Refugee Resettlement, that includes the Applicant's photograph, date of birth, name, and the address of the Applicant's sponsor, dated within the 12-month period immediately prior to the submission of the Application
14. <b>Common Access Card</b> , issued by the Department of Defense to active duty, retiree, or reservist military personnel, and to certain family members of such personnel
15. <b>Uniformed Services ID Card</b> , issued by the Department of Defense to active duty, retiree, or reservist military personnel, and to certain family members of such personnel
16. <b>Current Employment Authorization Document</b> ("EAD") or U.S. work permit, issued by the U.S. Citizenship and Immigration Services
17. <b>Enhanced Tribal Card, Native American Tribal Photo Identification Card</b> , or other tribal identification card issued by a federally recognized tribe (must include photo, address, signature, date of birth, and expiration date)
18. <b>U.S. Merchant Mariner Credential</b> , issued by the U.S. Coast Guard National Maritime Center (must include photo, address, date of birth, and issue and expiration dates)
19. <b>U.S. Department of State Driver's License or Non-Driver Identification Card</b> (must include photo, date of birth, and expiration date)
20. <b>Chicago Department of Family &amp; Support Services Participation Card</b>
21. <b>Illinois Person with a Disability Identification Card</b> , issued by the Illinois Secretary of State
22. <b>Temporary Identification Card for Released Offenders</b> , issued by the Illinois Department of Corrections
23. <b>Cook County Department of Corrections Identification Card</b>
